- Management's involvement and commitment to safety
- High level of employee and/or trade contractor involvement in safety
- New or innovative programs, practices, procedures or resources used by the company to promote safety
- Unique program elements used by the company to support and heighten safety awareness

The Qualitative Essays - This section allows an opportunity for you to provide a written description (qualitative description) of your company's safety program. Be creative. This is your opportunity to demonstrate that "special something" that sets you apart from the others—your core competency in safety. Explain the things that you do better than everyone else. Judges will be evaluating the following:

- Direct evidence of upper management/owner commitment
- Effectiveness safety program
- Hazard prevention and control
- Safety and health training
