Data is necessary in any grant application to support the project's "need." Data might include defining the target population, community (crime and poverty rates), education and training accessibility, and forecasted job growth across industries. The following is an overview of data sources.

  - ❖ Estimated offense volume and rate 20-year table presenting national estimates.
  - **Section** Estimated offense percent change for two years, five years, and ten years.
  - Estimated offense volume and rate by community type. o Estimated offense volume percent distribution by region. o Estimated offense volume and rate percent change by region, geographic division, and state.
  - Estimated offense volume and rate for each state by community type.
  - Estimated offense volume and rate for each individual metropolitan statistical area. o Estimated breakdown for the offenses of robbery (by location), burglary (by time of day), and larceny-theft (by type) over the last five years.

Rural Community Information (\*USDA defines rurality as open countryside with population densities less than 500 people per square mile and places with fewer than 2,500 people)
