How to Set Up A Ramp Billpay Account

General Information

National Association of Home Builders has fully integrated to ACH payments through Ramp Billpay for Member Savings Revenue Share. All future Member Savings Revenue Share payments will be completed via Ramp Billpay. Your HBA will need to create an account and provide your business account information in Ramp by May 30 to receive your royalty payment on or around June 6.
